

TERMS AND CONDITIONS

PLEASE NOTE THAT OUR INVOICE PAYMENT TERMS ARE NET 30 DAYS.

1. CUBING / LINEAR FOOTAGE RULES

Note that the greater between real weight and cubed weight will be used for rate calculation.

 - Minimum of 10 lbs per cubic foot : Québec, Ontario, Maritimes; Minimum of 15 lbs per cubic foot : Newfoundland
 - To calculate: cube = length (inches) x width (inches) x height (inches) divided by 1,728 x 10 or 15 depending on the province*
 - 5 skids and less or 11 feet of trailer and less, subject to 640 lbs per linear foot for Québec, Ontario and Maritimes
 - 5 skids and less or 11 feet of trailer and less, subject to 960 lbs per linear foot for Newfoundland
 - 6 skids and more or 12 feet of trailer and more, subject to 1,000 lbs per linear foot for all provinces
 - Long pieces (rolls, pipes, bundles, etc.) exceeding 8 feet long with the total diameter of:
 - ✓ Less than 8 inches: subject to 75 lbs per foot minimum
 - ✓ Between 8 and 18 inches: subject to 150 lbs per foot minimum
 - ✓ More than 18 inches: subject to 250 lbs per foot minimum

N.B. If the bill of lading states « DO NOT STACK » (or similar wording), the height of the shipment will be calculated at 8 feet (96 inches). The « lift space » or « skids space » needs to be noted on the original bill of lading by the shipper to be applicable.
